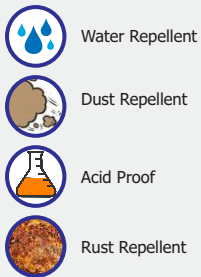


## PRODUCT OVERVIEW

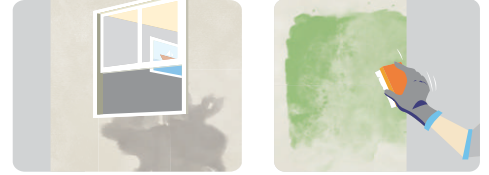

## SURFACE PREPARATION

- Clean the Surface thoroughly, as it should be free from dust, oil and etc.
- Remove existing Paint Layer/ Coating before applying "D.W.A.R"
- It is recommended to use wire brush followed by sanding with emery.
- Water wash the surface before "D.W.A.R" Application.



## APPLICATION PROCEDURES

- Apply 2-3 coats with spray, sponge or brush uniformly (wait for at least 30 minutes. after each coat.)
- Before application surface should be dry fully.

## Caution

The applicators and operators must be trained, experienced and have the understanding and equipment to mix/stir and apply the coatings correctly and according to Nushar technical protocol. Applicators and operators shall use appropriate personal protection when using these products.

## Health and safety

Please study the safety precautions mentioned on the container. Apply the products under well ventilated conditions. Ensure that spray mist is not inhaled and skin contact with the product should be avoided. Spillage on the skin should immediately be removed with suitable cleanser, soap and water.
